
1. Tank container fire: no cargo loss, no damage to environment or community.

A T11 tank container transporting Ethyl Alcohol was recently involved in a major fire on the highway in Brazil.

The fire resulted from the transporting chassis. Flames engulfed the tank causing the cladding and insulation to ignite. The tank was heavily damaged by the fire but the vessel remained leak-tight.

After the accident was resolved by the authorities, arrangements were made to transload the cargo into another tank and continue the planned journey.

The cargo was delivered to the plant where it was tested and accepted for discharge.





2. ITCO Members Meetings: postponed until 2021

Recognising the significant and unprecedented impact that COVID-19 will continue to have over the coming months, the ITCO Board has agreed to postpone the two 2020 ITCO Members Meetings - provisionally scheduled for Rotterdam and Singapore - until next year.

4. Guidance for Safe Entry into a Tank Container

ITCO has published its latest Technical Guidance document – "Safe Entry into a Tank Container".

This document provides guidance for ITCO member companies engaging in activities that require personnel to enter the interior of a tank for purposes such as inspection and maintenance. Tank entry presents inherent risks which require to be managed by implementing a safe entry process.

Where possible, process changes should be introduced to permit tasks to be carried out without entering the tank for example, by viewing the interior from the man-way or by the use of CCTV.



However, when personnel are required to enter a tank, appropriate safety procedures should be in place to minimise the risk. These are provided in these new ITCO Guidelines.

The current certification of a number of @TCO approved depots in Asia is due for renewal this year (each approved depot must be re-certified every 2 years).

Due to COVID-19 restrictions preventing a safe audit the current certification is extended until the end of December 2020, at which time the situation will again be reviewed.

B. ITCO June 2020 Technical Report

Regulatory meetings continue in "virtual" form during the period of COVID-19 restrictions. The UN Transport of Dangerous Goods meeting was held on-line in June 2020. RID-ADR is scheduled for September - as is IMO CCC7.

1. UN Transport of Dangerous Goods

This Meeting was updated with the progress made by the informal WG on FRP (Fibre reinforced plastic tanks) to develop regulations for the construction of UN Portable Tanks made of composite material FRP.

The main work - to develop a new Chapter 6.9 - has been completed. However, discussions to refine the work continue. Possibly a first draft of the formal proposal will be made to plenary in the December session with work continuing in 2021.

2. RID-ADR

A meeting was held by the informal WG on Tank Inspection. Issues relating to tank containers were summarised in the **May ITCO newsletter** - and the debate continues.

Discussion concerning the registration made a degree of progress subject to the agreement of plenary in September.

Proposed amendments to 6.8.1.5.1 require that type approval and inspections during manufacture shall be undertaken by an AIB (authorised inspection body) recognised by the country of the operator's registration. This is particularly an issue for leasing companies where the operator is often unknown at the time of manufacture.

A revised proposal would allow the operator to be registered in the country that recognised the AIB to undertake the inspections. This if agreed would help resolve the inspection at manufacturer for lease tanks.
