### 5. US Tariffs: Containers are not included on USTR Part 4 Tariff Lists

On Tuesday 13 August, the Office of the US Trade Representative (USTR) announced **next steps** on the proposed 10% tariff on certain Section 301 Part 4 commodities, noting that certain products will be removed from the tariff list and that the 10% tariff will be delayed on certain other products to 15 December 2019.

The USTR has published, on its website **List 4A** for which 10% tariffs will apply on 1 September 2019, and **List 4B** for which 10% Tariffs will apply on 15 December 2019.

ITCO can inform its members that "Containers" under HTS 8609 do not appear on either of the two tariff lists. Therefore, unless there is any additional applicability of Part 4 tariffs included in the upcoming Federal Register notice, containers will not be subject to the Part 4 tariffs.

# 6. New CDI Publication: "Packaged Chemicals by Sea: Risk Mitigation"

*"Packaged Chemicals by Sea: Risk Mitigation"* is the latest publication from the Chemical Distribution Institute. This CDI book provides insight into the entire, marine logistic distribution supply chain and the responsibilities of chemical manufacturers and their service providers.

## B. ITCO August 2019 Technical Report

### 1. Minimum Stacking Limit - IMO CCC6 (September 2019)

A joint paper submitted by BIC/WSC (CCC 6/13) to the IMO Cargo and Container Committee (CCC) meeting next month proposes to increase the CSC 1972 Annex II Chapter 2 Type Approval test

minimum stacking limit from the existing 192,000kg to 213, 000 kg (the figure that is stipulated in the current ISO 1496 editions).

A review of production statistics indicates that the majority of containers are constructed with a stacking strength at, or above, the 213, 000 kg figure stipulated in ISO 1496.

ITCO members are advised to check that current production is at 213,000kg or above.

While ITCO generally supports the increase to the CSC stacking limit, the BIC/WSC proposal makes a rather alarmist statement: "This gives rise to major safety concerns, including in regard to the risk of collapsing container stacks and containers lost overboard".

A perhaps unintended and regrettable consequence could be a call for identification marks for 192,000kg units.

### 2. RID-ADR Tank operator definition amendment

A proposal submitted has been submitted to the September 2019 RID-ADR Transport DG, Geneva meeting.

*"Tank-container/portable tank operator"* means any enterprise that operates a tankcontainer/portable tank. Where the operator is not the owner, the operator is the enterprise to which the tank-container/portable tank is leased or otherwise made available for use by a legally enforceable contract."

This addresses the requirement to re-define the registered owner of a tank container, to ensure that the financial owner (bank or lessor) is not defined within the regulations as the tank operator - and thereby subject to safety obligations beyond their control.

The proposal has been discussed at previous sessions of the Joint RID-ADR meeting but at the last Spring 2019 session an alternative definition was proposed requiring re-submission of the paper to the autumn session.

# 3. EN 17066.1 Insulated means of transport for temperature sensitive goods - Requirements and testing

This new standard is not obligatory, but it is useful for the tank industry as a means to uniformly apply insulation tests to new manufacture especially. Appendix C refers to tanks.

For the most part it aligns with ISO 1496-3 Tanks where insulation tests form part of the standard.

The document specifies the terminology, the requirements for thermal insulation, air tightness, test provisions test provisions for K-value containers with and without cooling and/or heating device.

### 4. Self-adhesive cladding patches

ITCO proposes to amend ACC to include the increasing use of self-adhesive cladding patches (SACPs) in in place of riveted patches. Although SACPs have been found to work well, there are issues to formalise - in regard to dimensions, damage over-lap and TIR approval.

The subject will be included in the Technical Session at ITCO Amsterdam. Members who are interested to develop ACC acceptance should contact the Technical Secretary
