# **B. ITCO February 2018 Technical Report**

- RID\_ADR Joint meeting
- Fibre-reinforced plastics (composite) portable tanks
- ISO 1496-3 tank containers specification and test
- Safety Molasses

## 1. RID-ADR Joint Meeting

- The next RID-ADR Joint Meeting will take place in March 2018.
- Agenda items include:
  - Template for Chapter 6.8 tank plates (unlike UN Portable tanks ADR does not provide a data plate format) and work is proposed to create a template (hopefully in line with UN)
  - Use of austenitic-ferritic stainless steels for the construction of tanks according to 6.8.5
  - Initial and periodic certificates of inspection of tanks signed and transmitted electronically
  - Welding on tanks responsibilities for welding approvals in the case of construction repair and modification of tanks EN ISO 15614-1 referenced via EN 14025:2013 + A1:2016

#### 2. Fibre-reinforced plastics (composite) portable tanks

- UN Transport Dangerous Goods Sub-Committee Work Group is tasked with the directive to draft the proposed UN regulation for construction and use of composite material tanks.
- The Work Group will be attended by ITCO

#### 3. ISO 1496-3 tank containers specification and test

- ISO 1496-3 Standard concerns the prototype testing of tanks.
- Following the review, it has been amended and is currently pending final acceptance votes by the ISO organisations for each country.
- The amendments are mostly updating of the old version. There are no significant changes.

#### 4. Safety – Molasses

- Members are reminded that both non-regulated and regulated dangerous goods can pose hazards.
- Tank Cleaning Journal 01.2018 reported that two men died in Australia during the cleaning of a tank that had last transported a sugar-cane by-product containing 4 percent urea.
- Personnel should not enter tanks without the due process of a valid tank entry permit.
